Arthaus rethinks future

WILLIAMSPORT - After showcasing bold, innovative and contemporary artwork for over eight years, the Executive Director of Arthaus Projects, John Yogodzinski, and the art gallery itself are at a crossroads.

While the intentions for the gallery have been (and always will be) good, a few events, comments, and reactions from the artist community and the community-at-large over the course of this past year have forced them to rethink how Arthaus Projects operates and what the future of the organization should truly be.

In order to properly determine the state of the gallery, Arthaus Projects began measuring attendance, sales and community response to each exhibit in more detail than previous efforts. In general, it was determined that solo exhibitions have not had the intended community impact, and the average time spent by gallery spectators is minimal. However, the data has also shown that group exhibitions, such as the annual juried show, bring the most impact and excitement to the community while visitors are found to challenge themselves with the works on display. While this data is not necessarily surprising, the logistical and organizational demands of group exhibitions make monthly showcases impossible. Additionally, the monthly requirements of transforming the space for each exhibition are too time intensive, stressful and costly. Therefore, Arthaus Projects has decided that instead of the traditional 10 exhibitions per year schedule, the gallery will showcase four, monthlong, high impact gallery exhibitions like the annual juried show. They believe that the "less is more" mantra is fitting for the gallery space. This does leave one big question - What will be displayed in the gallery space for the other eight months of the year? Arthaus is asking for help to figure that out.

Arthaus Projects is reaching out to the local artist community to keep the space viable and sustainable for the non-showcase months. Starting in January 2020, the gallery space will be transformed into a community-minded artisan space called the Williamsport Artisan Shop. Artists are asked to submit their work for consideration through the web site, www.arthausprojects.com, where more details can be found.

Arthaus Projects also plans to continue hosting artist-run classes and workshops in the gallery space. In order to be considered for a class, send your idea to john@arthausprojects.com.

OT rules change

MILTON - As of press time, the Fair Labor Standards Act overtime regulations were slated to be updated for the first time in 15 years, as of Jan. 1, 2020.

Thomas C. Marshall, Esquire, and Nicole M. Ippolito, Esquire, of McNerney, Page, Vanderlin & Hall, a law firm with expertise in all business law areas, provided a special informational session at a Seminar & Training Series event in mid-December.

The U.S. Department of Labor issued a final rulemaking in September, raising the federal overtime salary threshold to \$35,568 annually, or \$684/week, to start off the year. In PA alone, it makes an additional 61,000 workers now eligible for overtime.

"It's the (DOL's) position that this should be fairly easy to implement," Ippolito said. "The only real rule change is going to occur with the salary threshold level. The duties test and the salary basis test will remain the same.

"The reality of the situation is that the employees may be looking closer at their job descriptions, and their job performance, to see if they should be exempt or should be receiving overtime. So, there should be some HR work in respect to what employees are actually doing and what their job descriptions actually are, in order to make a determination if they fit in the exempt categories."

In addition, Gov. Tom Wolf's administration plans to implement rules in the coming years, including raising the threshold to \$40,560/annually in 2021 and \$45,550 in 2022, with automatic adjustments happening every three years, starting in 2023.

Employers would have to make financially sound decisions in regard to the changes, including: limiting working hours to 40 per week, raising salaries above the threshold or reducing base pay or benefits.


