If you've known her for any length of time, I'm sure you know this. And, our feature starting on the next page gives you some more of the back story and how she progressed.


Congratulations, Tea Jay! You are an inspiration to many! We've packed a lot more inside this month's issue.

# Ten years for Tea Jay

MILTON - Ask Central PA Chamber President & CEO Tea Jay Aikey what a "Chamber" is, and she'll be able to tell you all about it! Ten years ago, though, she didn't have a clue.

It was only by circumstances, including job loss, that she found her way to the Central PA Chamber. An active member at the time had let her know of an opening for someone who could serve as an administrative assistant and handle the bookkeeping. In fact, she didn't even know what the popular program Quickbooks was.

However, "I was never so sure that I was going to get that job," Tea Jay recalled, who felt good about her interview with the late Maria Culp, who was President & CEO at the time.

And, while she was offered the position, there was no one available to train her, and she started to figure things out on her own.

Learning quickly though, she began to make an impact in her role while she also looked up to Maria as a "strong female figure."

Within a few years, however, the late Bruce Smith took the helm of the Central PA Chamber, and this is when Tea Jay really came into her own.

Tea Jay remembers a time when she and Bruce would "butt heads," as she was showing a willingness to take on more responsibility that Bruce once held as Membership Director. But, he was someone who also encouraged her to develop as a professional and build her self-confidence.

"He told me one day I could (be president), but I thought 'no way,'" Tea Jay said.

Ultimately, she looked at Bruce as a mentor, and especially for his natural tendency to have the concern and care for others.

"His family even became my family," she said.

As many longtime members will recall, tragedy struck the Smith family and the whole Central PA Chamber family the day of Bruce's untimely passing in May of 2017. It left a hole in the hearts of many, and big shoes to fill for the next President & CEO of the Central PA Chamber. "I wasn't even going to apply," Tea Jay remembered.

However, through some encouragement by those close to her she did, with the attitude of "what do I have to lose?"

Considering the growth and prominence of the Chamber, the interview process was no easy feat, the second round even left Tea Jay in tears. Ultimately, she wasn't the board of director's first choice when the decision was made, but she accepted the position after the first choice for the job declined.

"Even then I needed a few days to think about it," Tea Jay said.

While she knew the membership inside and out, a glaring weakness in the eyes of the interviewers was her lack of experience in "economic development".

"I was going to show them, and they even told me to slow down," she said. "I had a chip on my shoulder."

Her signature accomplishment in economic development, to date, was bringing together numerous other decision-makers to apply for and receive Keystone Opportunity Zone statues for several properties in the Milton area.

March 16 is Tea Jay's 10th anniversary with the Chamber, and with hindsight looks back prudently on her personal accomplishments and even more so that of the nearly 116-year-old organization.

The building at 30 Lawton Lane that the Chamber calls home continues to see improvements on the inside - such as The Smith Room



# SVCEP makes big announcement

MILTON - The Susquehanna Valley Community Education Project (SVCEP) held a press conference on Jan. 28, at the Central Pennsylvania Chamber of Commerce to release the findings from an economic impact forecast of a proposed multi-county regional Susquehanna Valley community college.

The event was held live and virtually via Zoom.

Nationally recognized for more than 2,000 similar studies, Economic Modeling Specialists International (Emsi) conducted the research using formulas and proprietary data from national community college sector databases and from a detailed data survey and pro forma completed by the Susquehanna Valley Community Education Project's Finance and Fundraising Committee. The presenters reported new economic activity over the first 10 years of the community college's existence conservatively at \$78.5 million from four categories: capital spending, operations spending, student spending, and alumni financial contribution.

Short-run capital spending is projected to be \$13.1 million for multiple site locations across the sponsored service region delivering course instruction onsite and online both synchronous and asynchronous. Accounting for potential leakages, \$2.6 million would be retained in the service region. Long-run operations spending of the proposed community college is expected to be \$39.7 million and long-run student spending is anticipated at \$15 million. The long-run alumni contribution is based on 3,000 graduates in gainful employment contributing \$21.3 million in the first 10 years. Alumni contribution grows as more alumni are gainfully employed.

The annual economic impacts total \$16.7 million for a startup community college and break down as follows: operations of the community college are expected to be around \$5.3 million with annual student spending at \$3.3 million and \$8.1 million in total income each year added to the regional economy by alumni in the workforce. Alumni annual impact is expected to increase yearly with more graduates gainfully employed in the service region.

Pennsylvania state law requires local sponsorship and counties are the most stable sponsors. The recommended sponsorship of \$1.2 million is comparable to that of Cambria county's sponsorship of Pennsylvania Highlands Community College with a four-county

combined sponsorship by Northumberland County at \$624,000; Union at \$240,000; Montour at \$108,000; and Snyder at \$228,000. This breaks down to \$13.68 per household per year or \$1.14 per household per month in the four-county region. The return on this investment is expected to be 26.4 percent for every dollar invested that dollar is returned along with an additional \$2.50.

Letters of Support from businesses and municipalities across the four-county area are being sent to the county commissioners and a growing list is available on the SVCEP web site and petition letters can be submitted directly to county commissioners on the web site. SVCEP requests that readers write letters of support and sign petition letters for their county commissioners and copy the SVCEP on that correspondence.

# Homelessness grant open to Milton residents

MILTON - Residents at risk of losing their housing in Milton may be eligible to receive up to \$5,000 to prevent homelessness.

The Resident Subsistence Program is being offered in response to the COVID-19 pandemic to support hard-hit residents and is funded with a Northumberland County entitlement Community Development Block Grant-CARES Act (CDBG-CV).

The grants can be used to pay utility payments to prevent cutoff of service and rent/mortgage payments to prevent eviction.

Each eligible family may receive up to \$5,000, paid directly to the mortgage holder, landlord, or utility company on their behalf. Funds will not be given directly to families. Assistance is available for up to 100 days per family.

Applications are now being accepted. While there is no deadline to apply, the program is on a first-come, first-serve basis and ends when the funds are spent.

The Salvation Army will provide the grants to Milton residents, as allocated by the Borough of Milton. The Salvation Army is managing the program on behalf of the Borough. SEDA-Council of Governments (SEDA-COG) is administering the CDBG funds and ensuring compliance.

Applicants must be at risk of losing their housing and must provide documentation of it. Assistance can be made to families whose income is at or below the HUD Section 8 income limits for Northumberland County at the time of application. Applicants must complete an income verification interview to qualify for this program.
